## The purpose of this study

## The subjects of this study

- about 800 families of South Korea with children under the age of 7
- Data from the Korean Welfare Panel Study (KWPS) 2019.



## Research Question

1. What is the expenditure on private education for young children according to the child factors of the family in South Korea?
2. What is the expenditure on private education for young children according to the characteristics of the family in South Korea?
3. What is the expenditure on private education for young children according to householder's factors in South Korea?



# Data Analysis

- Frequency analysis,
- X2 test,
- and ANOVA analysis



## Research hypotheses

First, the participation of households with young children in private education will be affected by the order and age of their children's birth, the level of education of the head of the household, and the annual income.

Second, the average monthly spending on private education per child of a household with young children will be affected by the age of the first child, the number of children, the age of the father, the level of education for father, annual income, mother's employment status and household type.



## Discussion

- This study will be meaningful in analyzing the 10-year trend of spending on children's private education
- This study will show that the government should find ways to help children 's healthy growth and development by making and operating programs for each age level.
- This study will suggest the correct private education in South Korea by investigate the status of private education and the attitude of parents towards private education.
